THE CHALLENGE: SMALL-SCALE FILE SHARING

When Azunna Anyanwu, Chief Technology Officer at Aronson LLC, started with the firm in 2019, Aronson was using Sharefile for sharing documents with clients.

While that solution worked well for exchanging one or two documents, it wasn't tailored to the assurance process.


THE SOLUTION: SECURE FILE SHARING WITH SURALINK

When an employee who had used Suralink in a previous role joined the firm and recommended it, Anyanwu decided to look into Suralink as well as some other comparable solutions.

While Anyanwu performed his own analysis of the solution, the final decision was left to a cross-sectional committee of tax and audit team members—an approach that is central to how Anyanwu operates.

"IT can choose a platform on the backend, but if the front part of the business doesn't like it, you're going to have an uphill battle with adoption," Anyanwu says. "Massive implementation projects fail if you don't have shareholder buy-in."

After evaluating several potential solutions, the team chose Suralink.

THE RESULTS:

ALL-IN-ONE PLAT-FORM, TIME SAVINGS, SECURE FILE MANAGEMENT Initially, Aronson rolled out Suralink only to the audit department, but the firm's tax department started using Suralink within the year.

- O All-in-one platform. "Suralink is our only supported platform for clients that need to share files with us. Some of my guiding principles are simplicity, cloudfirst, security, and avoiding duplicate tools," Anyanwu says. "So I made the call that we would not support both Sharefile and Suralink." Now, employees and clients both appreciate how easy it is to collaborate on the Suralink platform.
- Time savings. While Aronson doesn't track metrics specifically around how much time they've saved by switching to Suralink, Anyanwu does track usage of the platform. They currently have 2,300 of their approximately 10,000 active clients on the platform, and around 90% use it weekly, if not daily.

Secure file management. Besides improved security, simplicity, and collaboration, the firm has also benefitted from having less data stored on its local network. Before implementing Suralink, people had to download files from Sharefile to the network, then upload those same files to CCH Axcess, Caseware, or another cloud-based system. Now, with Suralink's drag and drop functionality, people do a lot less downloading.

"That's important because it means we don't need to worry about maintaining those files, backups, ransomware, etc.," Anyanwu says. © Suralink suralink.com

THE CONCLUSION: SURALINK—A BIG WIN IN FILE SHARING

Anyanwu says he initially thought there would be clear segmentation between users of Suralink departments that didn't need it. But the Aronson team quickly realized the benefits of sharing files securely, having an audit trail, and collaborating outside of their email inbox.

"Our tax department even came up with an electronic organizer format in Suralink. It's a lot better than having a bunch of documents dumped in a folder," Anyanwu says. "Because of the flexibility of the Suralink platform, we were able to give access to everyone in the firm while improving security."

What's more, the firm has won new business, in part, due to its move to Suralink.
